ORDER

The present Writ Petition has been filed seeking a Mandamus as against the respondents to grant permission to set up Aavin Bunk Shop by considering the petitioner's representation dated 15.07.2025.

2. According to the learned counsel appearing for the writ petitioner, Madurai District Cooperative Milk Producers Union, by way of proceedings dated 24.04.2015, granted permission to the writ petitioner to run Aavin Booth. However, the respondents 1 and 2 herein have so far not considered the request of the petitioner for putting up Aavin Booth.

3. The learned Standing Counsel appearing for the respondents submitted that the petitioner has given a representation to the second respondent on 15.07.2025 which has been forwarded to the Assistant Commissioner (Revenue) of Madurai Corporation on 21.07.2025.
