This Writ Petition has been filed seeking to quash the impugned Demand Notice issued by the third respondent No. 324/2024 No.66-00-043729-000-0999 D-18/SRO/TLI/Ins II dated 20.02.2024 including the consequential recovery proceedings and for a consequential direction to the third respondent to consider and pass orders on the petitioner's waiver representation dated 11.03.2025.

2.With the consent of the parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3.Mr.N.Dilip Kumar, who takes notice for the respondents would submit after hearing the petitioner on 11.03.2025, an order came to be passed by the third respondent on 24.06.2025.
