PRAYER :- For Bail in Crime No.613 of 2025 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner, who was arrested and remanded to judicial custody on 04.12.2025 for the offences punishable under Sections 20(b)(ii)(B) and 8(c) of NDPS Act, in Crime No.613 of 2025 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner was found in illegal possession of 1.1 kgs of ganja. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offences as alleged by the prosecution. He further submitted that the petitioner is in judicial custody from 04.12.2025. Hence, he seeks bail to the petitioner.

4. The learned Additional Public Prosecutor submitted that 8 previous cases are pending against the petitioner Therefore, he opposed for grant of bail to the petitioner.

5. Taking into consideration the fact that even though eight previous cases are pending against the petitioner, the present case does not involve commercial quantity, this Court is inclined to grant bail to the petitioner, subject to the following conditions:

6. Accordingly, the petitioner is ordered to be released on bail on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties, each for a like sum to the satisfaction of the learned Additional District and Sessions Judge, Pudukottai, and on further conditions that :-

[a] the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhaar card or bank pass book to ensure their identity.

[b] the petitioner shall report before the Additional District and Sessions Judge, Pudukottai, daily at 10.30 a.m., and before the respondent police at 05.30 p.m., until further orders.

[c] the petitioner shall not tamper with the evidence
