ORDER

The present writ petition has been filed seeking a mandamus as against the second respondent to issue Work Site Inspection Certificate and the Working Condition of Plant and Machinery Certificate to the petitioner on or before 15.12.2025.

2. The learned Special Government Pleader appearing for the writ petitioner, on instructions, submits that in case, the petitioner makes a work site inspection, such a certificate would be issued. As far as the Working Condition of Plant and Machinery Certificate is concerned, it would depend upon the working condition of plant and machinery produced by the writ petitioner.

3. In view of the above said facts, the petitioner is directed to make a work site inspection **tomorrow(13.12.2025)** and produce the plant and machinery before the authority. On verification of the same, the authorities are directed to issue the certificates concerned **tomorrow(13.12.2025)** itself.



4. With the above said observations, this writ petition stands disposed of.
