In view of the same, without expressing any opinion on the merits of the matter, this Court directs the first respondent to consider and pass appropriate orders on the representation of the petitioner dated 03.11.2025, on merits and in accordance with law, and also taking into consideration the judgment and decree passed by the Principal District Judge, Tiruchirappalli, in OP No.52 of 1986 dated 03.03.1986, within a period of six weeks from the date of receipt of a copy of this order.
