The petitioner, who was arrested and remanded to judicial custody on 16.10.2025 for the offences punishable under Sections 296(b), 132 & 351(3) of BNS (Corresponding Sections 294(b), 353 & 506(ii) of IPC) and Section 25(1)(a) of Arms Act, in Crime No.458 of 2025 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner was creating problems in public with weapons and abused the police party using filthy language and threatened them with aruval. Hence, the complaint.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offences as alleged by the prosecution. He further submitted that the petitioner is in judicial custody from 16.10.2025. Hence, he seeks bail to the petitioner.

4. The learned Additional Public Prosecutor appearing for the respondent police opposed for grant of bail to the petitioner.

5. Taking into consideration of the facts and circumstances of the case and considering the nature of offence and also considering the period of incarceration suffered by the petitioner, this Court is inclined to grant bail to the petitioner, subject to the following conditions:

6. Accordingly, the petitioner is ordered to be released on bail on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each with two sureties, each for a like sum to the satisfaction of the learned Magistrate No.I, Srivaikundam, Thoothukudi District, and on further conditions that :-

[a] the petitioner and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their

Aadhaar card or bank pass book to ensure their identity;

[b] the petitioner is directed to report before the Dean, Thoothukudi Government Hospital, daily at 10.30 a.m, for two weeks and do social work in the hospital and thereafter, the petitioner shall report before the respondent police daily at 10.30 a.m., for a period of two weeks and thereafter, the petitioner shall report before the learned Judicial Magistrate daily at 10.30 a.m, for a period of two weeks and thereafter as and when required for interrogation;

[c] the petitioner shall not tamper with the evidence or witness either during investigation or trial;

[d] the petitioner shall not abscond either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial

Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner is released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560];

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 BNS.
