2. Considering the nature of the relief sought for, notice to the 3rd respondent is dispensed with.

The case of the prosecution is that due to previous enmity between the petitioner and the defacto complainant, the petitioner herein scolded the defacto complainant in filthy language, assaulted him and threatened him with dire consequences. Based on these allegations, an FIR has been registered against the petitioner.
