ORDER

This Writ Petition has been filed seeking issuance of a Writ of Mandamus, directing the second respondent to consider and dispose of the petitioner's Application No.2025/0103/15/516284 dated 25.09.2025 and to grant mutation and patta in favour of the petitioner in respect of Survey No.340/11A, measuring an extent of 0.16.23 hectares (40 cents), situated at Paluvangi East, Kavandampatti Village, Marungapuri Taluk, Trichy District.

2. By consent, the Writ Petition is taken up for final disposal at the admission stage itself.

3. The petitioner submits that she is the lawful owner of the land comprised in Survey No.340/11A, measuring 0.16.23 hectares (40 cents), situated at Paluvangi East, Kavandampatti Village, Marungapuri Taluk, Trichy District. The petitioner has submitted Application No.2025/0103/15/516284 dated 25.09.2025 seeking mutation and grant of patta in her name. Despite the submission of the application, no orders have been passed by the second respondent. Hence, the petitioner seeks a Writ of Mandamus directing the second respondent to consider and dispose of the application and grant patta in accordance with law.
