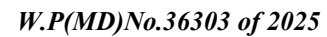

The present writ petition has been filed seeking a Mandamus as against the respondents for issuance of work site inspection certificate and working condition of the plants and machineries certificate to the Writ Petitioner in connection with the tender issued by the 1st respondent notice No. 15/2025-26/HDO/NH/ dated 02.12.2025 for the package No. TN-CRIF-2025-26-TRY-43.

2. By consent this Writ Petition is taken up for final disposal.

3. The petitioner has given representation on 15.12.2025, seeking issuance of the above said certificates.



5. In view of the above said facts, the petitioner is directed to conduct a site inspection on 23.12.2025 and produce the plant and soil samples before the authority. On verification of the plants and soil samples, the authorities are directed to issue the said certificate on or before 22.12.2025.
