However, despite registering the FIR in Crime No.55 of 2025, there is no progress in the investigation. Hence, the present Criminal Original Petition came to be filed.

3.The learned The Additional Public Prosecutor, on instructions, submitted that the case is all about trespass and hurt, and there is no mention of theft of 4 grams of jewelry in the complaint initially..

5.Considering the submissions of the learned counsel for the petitioner, the 2nd respondent is directed to monitor the investigation conducted by the 3rd respondent from time to time. The 3rd respondent is directed to apprise the
