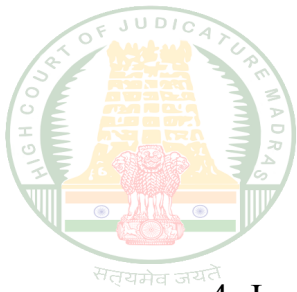

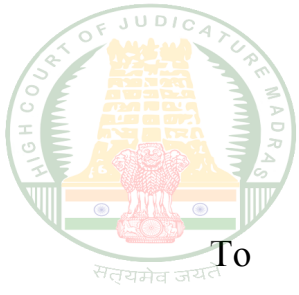
2. Learned counsel for the petitioners has also acknowledged the said fact.
