ORDER

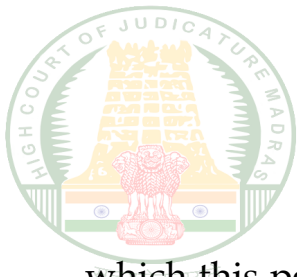
(Order of the Court was made by J.NISHA BANU, J.)
