ORDER

(Order of the Court was made by A.D.JAGADISH CHANDIRA, J.)

The present contempt petition has been filed to punish the respondents for willful disobedience of the order of this Court in W.P(MD)No.19810 of 2024 dated 02.09.2024.

2. When the matter is taken up for hearing today, the learned Additional Government Pleader appearing for the respondents has produced a copy of the Status Report of the Tahsildar, Nilakottai. He would submit that pursuant to the same, a survey was conducted in S.No.847/41 at Mannavarathi Silukkuvarpatti Village, Nillakottai Taluk, Dindigul District, which is classified as Sarkar Pormaboke to an extent of 0.03.00 acres and the A Register at the remarks column has been marked as Santhana Karuppasamy kovil, vacant land and further it was found that five persons have encroached the property in S.No. 847/41 as follows:-
