2. A perusal of the records reveal that the petitioner was placed under suspension on 29.01.2024, pursuant to his involvement in a criminal case. It is the grievance of the writ petitioner that, so far subsistence allowance has not been paid to him. The petitioner has given a representation to the respondents on 11.11.2024, seeking subsistence allowance. Since the same has not been answered, the present writ petition has been filed.

4. Considering the above said facts, the second respondent is directed to disburse the eligible subsistence allowance to the writ petitioner within a period of four weeks from the date of receipt of a copy of this order.
