2.Today, when the matter came up for hearing, the learned Government Advocate (Crl. side) submitted that based on the complaint given by the petitioner, enquiry was conducted in C.No.R4/3192/64806/2024. He further submitted that a case in Crime No.577 of 2024 for the offence under Sections 296(b), 126(2), 329(4) and 351(2) of BNS was registered against the petitioner's father on 26.11.2024 and hence, the present complaint appears to be a defence case.
