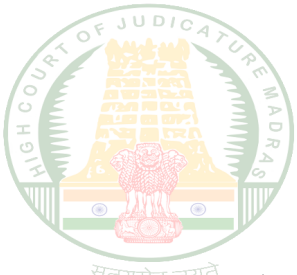

3. Accordingly, this Writ Miscellaneous Petition is dismissed as withdrawn.”

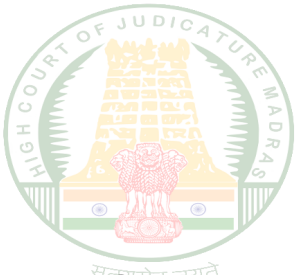
