ORDER

Though the writ petition has been filed seeking a direction to consider the representation of the petitioner dated 22.11.2024, to survey and identify the acquired lands in S.No.437/8, Eraniel Village, Kanniyakumari District and consequently pay a compensation to the petitioner, today the learned Additional Government Pleader appearing for the respondents would bring to my notice that even as early as on 28.12.2024, survey has been conducted. He would also invite my attention to the communication dated 27.01.2025 in this regard. The said communication confirms the fact that in respect of the petitioner's house

and valuation thereof, action has already been initiated and upon receipt of the valuation, the compensation shall be released to the petitioner.

2. Recording the statement of the learned Additional Government Pleader appearing for the respondents that after valuation, compensation would be released to the petitioner, the writ petition stands closed. However, liberty is granted to the petitioner to file a fresh petition, in the event of being aggrieved by any order that may be passed by the respondents.

3. With the above liberty, the writ petition is closed. No costs. Consequently, connected miscellaneous petition is closed.
