PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to pay the petitioner interest at the rate of 18% per annum, the period of delay from 01.03.2023 to 29.10.2024 in paying the amounts paid towards my terminal/pension benefits namely EPF Employee's Contribution, Gratuity, Encashment of leave and Commuted Value of Pension.

ORDER

The instant writ petition has been filed by a retired employee of the respondent Transport Corporation, seeking a mandamus directing the respondents to pay interest at the rate of 18% per annum for the belated payment of petitioner's terminal benefits.

2. According to the learned Counsel appearing for the writ petitioner, the petitioner was appointed in the respondent Transport Corporation on 27.04.1997, and he had attained superannuation on 28.02.2023. The terminal benefits were disbursed belatedly to the writ petitioner only on 30.10.2024. Hence, he sent a representation on 10.11.2024, seeking interest for the belated payment. Since, there is no response from the respondents authorities, the present writ petition has been filed.
