The petitioner has already appeared for enquiry on 23.11.2023 at 04.00 p.m., before the 2nd respondent in his office. However, the said enquiry is kept pending endlessly without conclusion for the past more than one year. Hence, this writ petition came to be filed condemning the callousness attitude of the 2nd respondent in concluding the enquiry initiated as early as in the year 2023.
