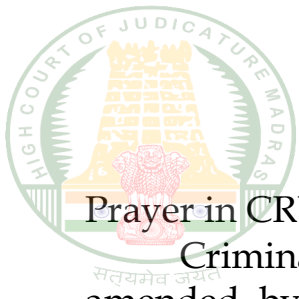

Criminal Appeal is filed under Section 14(A)(2) of SC/ST (POA) Act, 2015 as amended by Act 1 of 2016, to call for the records relating to the order, dated 15/07/2024 made in CRL MP(MD)No.2503 of 2024 on the file of the learned II Additional District and Sessions Court(PRC), Tirunelveli, dated 15.07.2024 and set aside the same as illegal and enlarge the appellant on bail.

ORDER

This Miscellaneous Petition has been filed to relax the condition imposed on the petitioner in Crl.M.P.(MD).No.11661 of 2024 in Crl.M.P.(MD).No.9773 of 2024 in Crl.A.(MD).No.605 of 2024 dated 29.10.2024 on the file of this Court.
