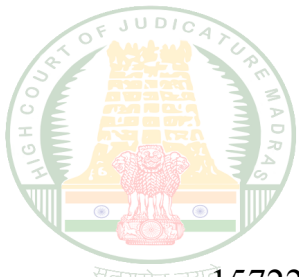

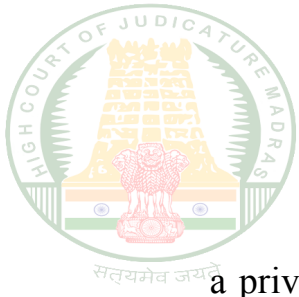
ORDER

2.The petitioner association obtained a direction for removal of encroachment vide order dated 08.09.2017 in W.P(MD)No.15722 of 2016. Contending that the direction given by the Court has not been complied with, this Contempt Petition came to be filed.

3.The learned Standing Counsel submitted that as early as on 14.12.2017, the petitioner has been informed that the subject property is

a private property and that therefore the Corporation cannot remove the so called encroachment.
