ORDER:

Petitioner, who is arrayed as accused, in S.C.No.60 of 2024 on the file of the Principal Additional Sessions Judge, Karimnagar, registered for the offence under Section 306 of IPC, is seeking to quash the proceedings against him.

2. Heard Sri V.Krishna Swaroop, learned counsel for petitioner and Sri Jithender Rao Veeramalla, learned Additional Public Prosecutor appearing for the respondent-State and perused the record.

3. Though the petition is filed for quashing the proceedings, during the course of arguments, learned counsel for the petitioner has restricted his prayer to the extent of dispensing with the presence of the petitioner/accused before the trial Court.

4. Hence, this petition is disposed of dispensing with the appearance of the petitioner/accused before the trial Court unless his presence is specifically required during the course of trial, subject to the condition of petitioner being represented by his counsel on every date of hearing.

Pending miscellaneous applications, if any, shall stand closed.
