COMMON ORDER

This Writ Petition is filed seeking to declare the action of the respondents in not allowing the petitioner to discharge duties as Special Officer, KGBV School, Tandur (Village and Mandal), Mancherla District, in the guise of the impugned proceedings issued by the 2nd respondent in Proc.Rc.No.1018/SSA/T9/KGBV/2016, dated 05.10.2016, placing the petitioner under suspension, and the consequential proceedings issued by the 3rd 4th respondents dated 06.10.2016, as illegal and arbitrary.

2. Heard Sri D. Linga Rao, learned counsel for the petitioner, and learned Government Pleader for Services-I, appearing on behalf of the respondents.

3. Today, when the matter is taken up for hearing, learned Government Pleader for Services-I, appearing on behalf of the respondents, submits that the orders passed in W.P.M.P.No.3977 of 2017 in W.P.No.3345 of 2017, dated 01.02.2017 had been complied with, and to that effect, he has placed on record written instructions issued vide Rc.No.A1/2722/2019, dated 06.12.2025. He further submits that no further orders are required to be passed in this Writ Petition.

4. In view of the above submissions, the Writ Petition is closed. There shall be no order as to costs.

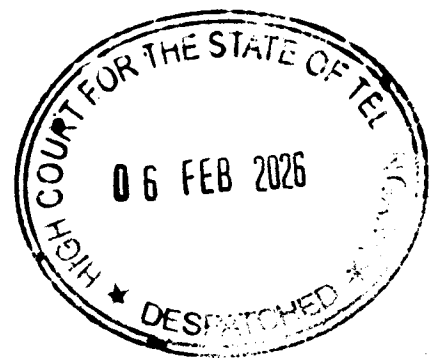
