ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 by the petitioner/accused seeking to quash the C.C.No.59 of 2017 on the file of learned XIV Metropolitan Magistrate, Cyberabad, L.B.Nagar, Rangareddy District, registered for the offences punishable under Sections 498-A of Indian Penal Code, Sections 3 and 4 of Dowry Prohibition Act.
