ORDER:

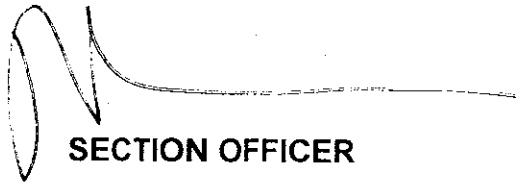

3. In view of the above submission, the Contempt Case is closed. Miscellaneous petitions, if any pending, shall stand closed.

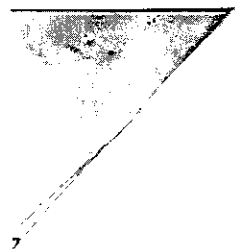
