ORDER:

Heard Sri K.Rathanga Pani Reddy, learned counsel for the petitioners, Smt. S.Sravanthi, learned Assistant Government Pleader for Revenue appearing for respondent Nos.1 to 3 and Ms. G.Jhansi, learned counsel appearing for respondent No.4. Perused the material on record.

2. Learned Assistant Government Pleader for Revenue, basing on the letter dated 01.05.2025 bearing Lr.No.B/315/2025 issued by respondent No.3, submits that the petitioners' allegation that the respondents commenced laying the road, but instead of laying it to the existing 20 foot width pathway, laid a 30 foot wide road by taking

over the petitioners' land without acquiring the same, is false and baseless. Further, the respondents have not interfered with the possession of the petitioners over the subject lands and the road has been laid strictly in accordance with the tonch map. Therefore, the petitioners' allegation that the respondents have not complied with the orders of this Court is also false and baseless. In view of the same, the cause no longer survives for adjudication and no further orders are required to be passed in this matter.

3. On the other hand, learned counsel for the petitioners seeks liberty for the petitioners to approach appropriate authority for redressal of their grievances.

4. In view of the above submissions made by both sides, this Contempt Case is closed, granting liberty to the petitioners to agitate their rights before the appropriate forum in accordance with law. There shall be no order as to costs.

Miscellaneous petitions, if any, pending shall stand closed.

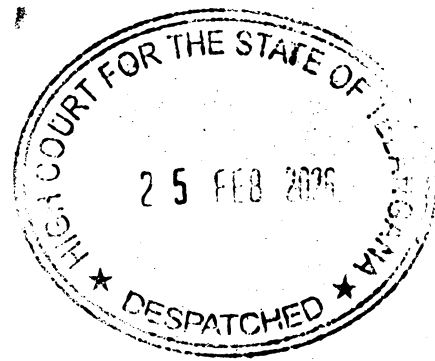
