ORDER:

The writ petition is filed with the following prayer:

"To issue a writ, order or direction more particularly one in the nature of writ of Mandamus declaring the action of the respondents in not considering and disposing of the representation dated 27.7.2020 by enhancing the age of superannuation is arbitrary and illegal and consequently issue a direction to the respondents to consider and dispose of the representation dated 27.7.2020".

2. Today, when the writ petition is taken up for hearing, the learned counsel appearing for the respondents submits that the representation of the petitioners dated 27.7.2020 was considered and rejected by the respondent No.2 vide proceedings Rc.No.4434/2020 UB2 dated 9.9.2020.

3. Recording the above, the writ petition is closed, leaving it open to the petitioners to challenge the said proceedings dated 9.9.2020 if they still aggrieved. As a sequel thereto, miscellaneous applications, if any, pending in this writ petition stand closed. There shall be no order as to costs.

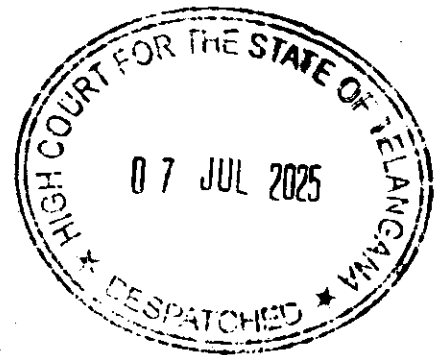
