This Contempt Case is filed alleging willful disobedience and non-compliance of the order of this Court dt.23.04.2024 in W.P.No.7132 of 2024.

Today, when the matter is taken up for hearing, Sri B.Mayur Reddy, learned Senior Counsel appearing for Sri Saini Aravind, learned counsel for the petitioner and Sri G.Madhusudhan Reddy, learned Standing Counsel appearing on behalf of the respondent, would submit that the authorities have removed/demolished the unauthorized and illegal construction on 11.11.2024.
