This Criminal Petition is filed by the petitioner/accused No.1 seeking to quash the C.C.No.336 of 2022 on the file of the learned Judicial Magistrate of First Class, at Laxshatipet for the offences punishable under Sections 498-A r/w 34 of I.P.C. and Sections 3 and 4 of the Dowry Prohibition Act.
