No. 1198/2020 on the file of the Court of the IX ACMM Kukatpally as this Honourable Court may deem fit and proper in the facts and circumstances of the case b) Pass an appropriate order(s) / direction(s) thereby permitting the Petitioner herein to furnish a personal bond and one surety in the like amount to the satisfaction of the court concerned in any one case and the same upon being furnished be treated to be valid in all other cases, where the bail order has been passed and c) In the alternative to prayer (a) and (b), pass an appropriate order thereby directing modification of the conditions imposed vide the respective bail orders to the extent that surety amounts be reduced suitably to extent as deemed fit and proper by this Hon'ble Court. d) Pass an appropriate order thereby either setting aside or modifying the condition to appear before the concerned SHO of the Police Station on different dates in view of the fact that the petitioner herein is not a local resident of State of Telangana.

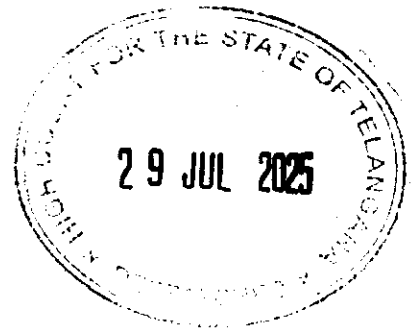
