Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of Writ of Mandamus, declaring the order of the 1st respondent dated 26.03.2011 made in Case No.CS6/1970/2010 without examining reports submitted by the authorities, without considering the available records and the proceedings of the 2nd respondent dated 07.05.2010 made in J/1996/2010 cancelling Petitioner's authorization of the Fair Price Shop No.2 of Addakal Village and Mandal, Mahabubnagar District and consequential proceedings No. D/2186/2009 of dated 29.06.2009 of the 3rd respondent without any intimation to petitioner made in alternative arrangements for distribution of essential commodities through the Fair Price Shop No.2 of Addakal Village and Mandal, Mahabunagar without fault of mine, without assigning any reasons as arbitrary, illegal, fault of mine, wihtout assigning any reasons as arbitrary, illegal, unjust, violative of the principles of natural justice violative of the principles of natural

justice , violative of the fundamental rights guaranteed to me under Article 14, 19 and 21 of the constitution of India in view of the facts and circumstances set out hereunder.

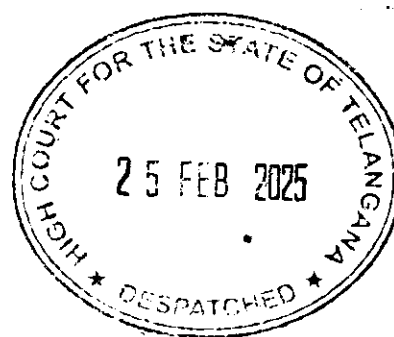
