Heard Sri J.Sreenath Reddy, learned counsel for the Official Liquidator.

2. Having satisfied with the reasons mentioned in the supporting affidavit, and upon considering the half-yearly accounts filed by the learned Official Liquidator, this application is ordered with the following:-

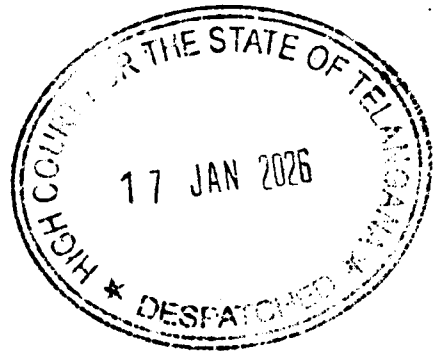
