Heard Sri P. Ramachandran, learned counsel for the petitioner and Sri. B. Mallikarjuna Reddy, learned counsel for the respondent. Perused the entire record.

2. This Transfer Civil Miscellaneous Petition is filed under Section 24 of the Code of Civil Procedure, 1908, by the petitioner-wife to transfer F.C.O.P.No.68 of 2023 pending on the file of the Family Court-cum-II Additional District and Sessions Judge at Nizamabad to any Family Court at Kukatpally.

3. Learned counsel for the respondent reported no objection.

4. In view of the consensus arrived between the parties, the relief sought by the petitioner is granted by transferring F.C.O.P.No.68 of 2023 from the file of the Family Court-cum-II Additional District and Sessions Judge at Nizamabad, to the file of the learned III Additional District and Sessions Judge – cum – Principal Family Court, Medchal-Malkajgiri District at Kukatpally.

5. In the result, the Transfer Civil Miscellaneous Petition is **allowed**. F.C.O.P.No.68 of 2023 stands transferred from the file of the Family Court-cum-II Additional District and Sessions Judge at Nizamabad, to the file of the learned III Additional District and Sessions Judge – cum – Principal Family

Court, Medchal-Malkajgiri District at Kukatpally. The entire original record shall be transmitted within a period of one month. There shall be no order as to costs. Miscellaneous Petitions, if any, pending, shall stand closed.
