ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 by the petitioners/accused Nos.3 and 4, seeking to quash the Cr.No.736 of 2021 on the file of Jawahar Nagar Police Station, Rachakonda, registered for the offences under Sections 498-A, 506 of Indian Penal Code, Sections 3 and 4 of Dowry Prohibition Act.

2. Ms.Kalpana, learned counsel represented on behalf of petitioners.

3. When the matter is taken up for hearing, learned Assistant Public Prosecutor, by furnishing a copy of written instructions would submit that investigation is completed in this case and charge sheet is filed before the designated criminal Court. Therefore, he seeks to dismiss the Criminal Petition as infructuous.

4. Recording the submissions made by the learned Assistant Public Prosecutor and taking the copy of written instructions onto the file, this Criminal Petition is dismissed as infructuous granting liberty to the petitioners to move a fresh petition in case the cause survives.

Miscellaneous applications, if any pending, shall also stand closed.

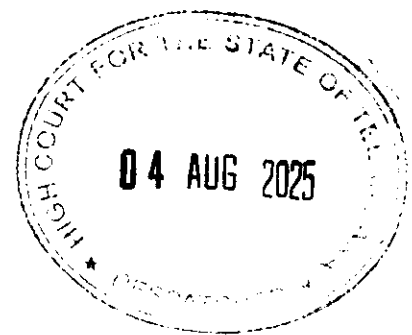
