Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus by declaring the action of the 2nd to 4th respondent in not conducting the enquiry in respect of the assignment of land made in favour of the 5th respondent in Sy.No. 328/1/2 to an extent of Ac. 0.08 Guntas, situated at Ponakal Village, Jannaram Mandal, Mancherial District is illegal, arbitrary and unconstitutional and contrary to the GO Ms. No. 940 Revenue (Asn-I) Department dated 24-11-1998 consequently direct the 2nd to 4th respondent to conduct the enquiry in respect of the assignment of land made in favour of the 5th respondent in Sy.No. 328/1/2 to an extent of Ac. 0.08 Guntas, situated at Ponakal Village, Jannaram Mandal, Mancherial District and cancel the Assignment made in favour of the 5th respondent.
