There shall be interim suspension of the order dated 26.11.2024 passed in Crl.M.P.No.137 of 2024 in M.C.No.278 of 2022 by the learned I Additional Family Court-cum-XIV Additional Metropolitan Sessions Judge, Hyderabad, subject to the petitioner paying maintenance @ Rs.30,000/- per month to respondent Nos.1 to 3 herein on or before 10th of every succeeding month, from the date of this order. The arrears, if any, shall also be paid @ Rs.30,000/- per month to respondent Nos.1 to 3 herein, within four (04) months from today.
