ORDER:

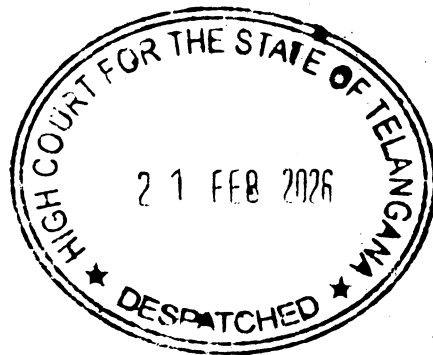
