Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not paying the compensation to the petitioner for the land acquired i.e. Plot No.35 admeasuring 250 sq.yards in Sy.Nos. 388, 423, 424, 425, 426, 427, 428, 429, 449 and 450 in Sri Sai Archana Enclave situated at Tharamathipet Village, Hayathnagar Revenue Mandal, Ranga Reddy District in spite of their undertaking in P.L.C.No. 151 of 2011 on the file of Lok Adalat, L.B.Nagar, Ranga Reddy District as illegal, arbitrary and contrary to law and violative of Article 300-A of the Constitution of India.
