1. Learned State counsel has supplied the copy of Litigation Policy dated 11.07.2025 in Court today and the same is taken on record. He draws the attention of the Court to Clause 5 (B) of the Litigation Policy which provides detailed mechanism of Grievance Redressal System. He submits that in view thereof, the petitioners have an effective alternate remedy and they should be relegated to the same.

2. Learned counsel appearing on behalf of the petitioners do not controvert the said position, however, they contend that the issue of limitation, if any, should not be taken against the petitioners on account of the fact that the petitioners had already approached this Court by way of filing the instant writ petition.

3. The said prayer is not opposed by the learned counsel appearing on behalf of the respondents.

4. In view thereof, the present petition is disposed of with liberty to the petitioners to raise their grievances in consonance with the Litigation Policy dated 11.07.2025. It is expected that the grievance of the petitioners shall be decided by the concerned authorities as expeditiously as possible.
