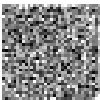

The instant petitions have been filed by the petitioner(s) under Section 482 Cr.PC for quashing of FIR No.35, dated 14.08.2021, registered under Sections 406, 498-A and 120-B IPC, at Police Station NRI, Police Commissionerate Ludhiana, District Ludhiana.

Learned State counsel and counsel appearing for respondent No.2 have produced a copy of the order dated 01.10.2024, passed by Judicial Magistrate 1st Class, Ludhiana and submit that both the petitioners have been



declared proclaimed persons vide order dated 30.01.2024 and challan has been presented against them. The said order dated 01.10.2024 is as under:-

“Perusal of the case file reveals that both the accused persons namely Manpreet Arora and Suman Arora were already declared proclaimed persons, vide order dated 30.01.2024 and challan has been presented qua the proclaimed persons namely Manpreet Arora and Suman Arora.

Today, PW-1 ASI Amrik Singh is present and examined U/s 299 Cr.P.C. No other PW is present. The remaining evidence u/s 299 Cr.P.C is hereby dispensed with. Prosecution has not placed on record list of property of accused Manpreet Arora and Suman Arora till today for proceedings under Section 83 of Cr.P.C and the prosecution is hereby given liberty to move separate application for attachment of property of accused Manpreet Arora and Sumar Arora as and when they found the property of accused. No further action is required. Accordingly, the present file is ordered to be consigned to record room and revived as and when, the accused Manpreet Arora and Suman Arora surrendered before the court or arrested by the police.”

In this view of the matter, since both the petitioners have been declared proclaimed persons, no relief can be granted in the present petitions.

Dismissed.
