1. The present application has been preferred under Section 378(4) of the Code of Criminal Procedure, 1973 (hereinafter 'CR.P.C.') seeking grant of leave to appeal the judgment of acquittal dated 13.12.2018 passed by the learned Judicial Magistrate Ist Class, Sri Muktsar Sahib in a case stemming from complaint dated 09.06.2016 filed under Sections 500/506/34 of Indian Penal Code (hereinafter to be referred as 'IPC').

2. Tersely put, the facts of the case are that the applicant had moved a complaint against depot holders i.e. respondents No. 2 and 3 on the allegations that they had manipulated their record pertaining to kerosene oil and other ration articles and an inquiry in this regard was marked to Gurtar Singh, District Food Supply Officer, Sri Muktsar Sahib. Applicant further alleged that during the said inquiry, respondents No. 4 to 10 raised false allegations against the applicant regarding his character stating that he was habitual of making false complaints and blackmailing officials/officers. Thus, the applicant filed complaint(supra) against the respondents. After assessing all the material available on the record, the learned trial Court acquitted the respondents vide judgment dated 13.12.2018.



3. The Hon'ble Supreme Court in ***M/s. Celestium Financial vs. A. Gnanasekaran Etc., 2025(3) RCR (Criminal) 208***, after considerable discussion and comparative interpretation of Sections 372 and 378(4) of Cr.P.C., concluded that the victim has a right to file an appeal under Section 372 of Cr.P.C. before the Court of Sessions. Speaking through Justice B.V. Nagarathna, the following was held:

“7.12 The reasons for the above distinction are not far to see and can be elaborated as follows:

Firstly, the victim of a crime must have an absolute right to prefer an appeal which cannot be circumscribed by any condition precedent. In the instant case, a victim under Section 138 of the Act, i.e., a payee or the holder of a cheque is a person who has suffered the impact of the offence committed by a person who is charged of the offence, namely, the accused, whose cheque has been dishonoured.

Secondly, the right of a victim of a crime must be placed on par with the right of an accused who has suffered a conviction, who, as a matter of right can prefer an appeal under Section [374](#) of the CrPC. A person convicted of a crime has the right to prefer an appeal under Section 374 as a matter of right and not being subjected to any conditions. Similarly, a victim of a crime, whatever be the nature of the crime, unconditionally must have a right to prefer an appeal.

Thirdly, it is for this reason that the Parliament thought it fit to insert the proviso to sub-section 372 without mandating any condition precedent to be fulfilled by the victim of an offence, which expression also includes the legal representatives of a deceased victim who can prefer an appeal.

On the contrary, as against an order of acquittal, the State, through the Public Prosecutor can prefer an appeal even if the complainant does not prefer such an appeal, though of course such an appeal is with the leave of the court. However, it is not always necessary for the State or a complainant to prefer an appeal. But when it comes to a victim's right to prefer an appeal, the insistence on seeking special leave to appeal from the High Court under Section [378\(4\)](#) of the CrPC would be contrary to what has been intended by the Parliament by insertion of the proviso to Section [372](#) of the CrPC.

Fourthly, the Parliament has not amended Section 378 to circumscribe the victim's right to prefer an appeal just as it has with regard to a complainant or the State filing an appeal. On the other hand, the Parliament has inserted the proviso to Section 372 so as to envisage a

superior right for the victim of an offence to prefer an appeal on the grounds mentioned therein as compared to a complainant. Fifthly, the involvement of the State in respect of an offence under Section 138 of the Act is conspicuous by its absence. This is because the complaint filed under that provision is in the nature of a private complaint as per Section 200 of the CrPC and Section 143 of the Act by an express intention incorporates the provisions of the CrPC in the matter of trial of such a deemed offence tried as a criminal offence. Therefore, the complainant, who is the victim of a dishonour of cheque must be construed to be victim in terms of the proviso to Section 372 read with the definition of victim under Section 2(wa) of the CrPC.”

4. In view of the judgment rendered by the Hon’ble Supreme Court in **Celestium Financial (supra)** and this Court in **Satish Kumar vs. Jugal Kishor** in **CRM-A-2700-MA-2018** decided on 02.07.2025, the learned Sessions Judge, Sri Muktsar Sahib is directed to treat the present leave to appeal as an appeal filed under Section 372 of the Cr.P.C. and entrust the same to appropriate Court for its disposal.
5. The Registry is directed to send the complete paperbook and the record of the case to the learned Sessions Judge, Sri Muktsar Sahib forthwith.
6. Disposed of accordingly.
7. Pending miscellaneous applications, if any, also stand disposed of.
