1. The prayer in the present petition is to set aside the judgment dated 07.02.2025 passed by learned Additional Sessions Judge, Rewari vide which judgment of conviction and order on quantum of sentence dated 24.04.2018/25.04.2018 passed by learned Judicial Magistrate Ist Class, Rewari have been upheld, whereby the petitioner has been convicted under Sections 279 and 304-A of Indian Penal Code (hereinafter to be referred as ‘IPC’) in the case stemming from FIR No. 182 dated 29.11.2014 registered at Police Station Sadar, Rewari.
2. The petitioner was convicted for driving the offending vehicle trollea bearing registration No. RJ-14GC-6124 in a rash and negligent manner, which caused the accident and resulted in death of the deceased-Sher Singh and sentenced, as mentioned below:

3. Learned Counsel for the petitioner submits that he is not assailing the impugned judgment of conviction dated 07.02.2025 passed by learned Additional Sessions Judge, Rewari on merits and restricts his prayer to modification of the order on quantum of sentence dated 25.04.2018 passed by learned Judicial Magistrate Ist Class, Rewari to that of sentence already undergone by the petitioner as he has already undergone a period of 03 months and 02 days out of total sentence of 01 year imposed upon him and he is not involved in any other case.

4. Per contra, learned State counsel opposes the prayer of the petitioner on the ground that learned trial Court has passed a well-reasoned judgment based on correct appreciation of evidence available on record and the said judgment and order of sentence have also been upheld by learned lower Appellate Court and as such, the petitioner does not deserve any leniency.

5. Having heard learned counsel for the parties and after perusing the record with their able assistance, it transpires that the petitioner was convicted for driving the offending vehicle trola bearing registration No. RJ-14GC-6124 in a rash and negligent manner, which caused the accident and resulted in death of the deceased-Sher Singh, attracting the offences under Section 279 and 304-A of IPC, for which no minimum punishment has been prescribed. As per his custody certificate, he is not involved in any other case and has already undergone an actual sentence of 03 months and 02 days out of total sentence of 01 year in the instant case. Moreover, learned counsel for the petitioner has not assailed the judgment of conviction on merits. Rather, he has restricted his prayer only qua modification of order on quantum of sentence. Since there is no minimum punishment prescribed under Sections 279 and 304-A of IPC, this



Court is of the opinion that it would be in the interest of justice, if the sentence awarded to the petitioner is reduced to the period already undergone by him.

6. In **Deo Narain Mandal v. State of UP (2004) 7 SCC 257**, a three Judge bench of the Hon'ble Supreme Court has opined that awarding of sentence is not a mere formality in criminal cases. When a minimum and maximum term is prescribed by the statute with regard to the period of sentence, a discretionary element is vested in the Court. Background of each case, which includes factors like gravity of the offence, manner in which the offence is committed, age of the accused, should be considered while determining the quantum of sentence and this discretion is not to be used arbitrarily or whimsically. After assessing all relevant factors, proper sentence should be awarded bearing in mind the principle of proportionality to ensure the sentence is neither excessively harsh nor does it come across as lenient.

7. Further, a two Judge Bench of the Hon'ble Supreme Court in **Ravada Sasikala v. State of AP AIR 2017 SC 1166**, has reiterated that the imposition of sentence also serves a social purpose as it acts as a deterrent by making the accused realise the damage caused not only to the victim but also to the society at large. The law in this regard is well settled that opportunities of reformation must be granted and such discretion is to be exercised by evaluating all attending circumstances of each case by noticing the nature of the crime, the manner in which the crime was committed and the conduct of the accused to strike a balance between the efficacy of law and the chances of reformation of the accused.

8. A perusal of the judgment of conviction passed by the learned trial Court indicates no perversity in its findings and the said judgment is based on correct appreciation of evidence available on record. However, the FIR (supra)

was lodged on 29.11.2014 and the petitioner has been suffering the agony of trial for last more than 10 years. Since his conviction, he has grown into a law-abiding citizen and desires to live a peaceful life.

9. Therefore, in view of the discussion above, the present petition is disposed of in the following terms:-

(i) The judgment dated 07.02.2025 passed by the learned Additional Sessions Judge, Rewari is upheld.

(ii) The order of sentence dated 25.04.2018 passed by learned Judicial Magistrate Ist Class, Rewari is modified to the extent that the sentence of rigorous imprisonment for 01 and total fine of Rs. 600/- with default mechanism awarded to the petitioner is reduced to the period of sentence already undergone by him.

10. Pending miscellaneous application(s), if any, shall also stand disposed of.

11. Petitioner be released from the custody, if not required in any other case.
