1. Instant petition under Section 528 of the Bharatiya
Nagarik Suraksha Sanhita 2023 (BNSS) has been preferred seeking
direction to the official respondents to take legal action on the
complaint dated 12.11.2024 (Annexue P-5) filed by the petitioner.

2. Heard.

3. It is submitted by learned counsel for the petitioner that
aggrieved by the act and conduct of the private respondent, the
petitioner had moved a representation dated 03.01.2025 (Annexure P-
6) to the Commissioner of Police, Police Commissionerate, District
Ludhiana, and the Senior Superintendent of Police, Khanna, District
Ludhiana.

4. Learned counsel for the petitioner further contends that the Senior Superintendent of Police, respondent No. 3 has closed the complaint dated 12.11.2024 (Annexure P-5) as per Annexure P-7 without any rhyme or reason, however, the same is pending before the Commissioner of Police, Ludhiana-respondent No. 2. He contends that for the purpose of the present petition, the petitioner will be satisfied if appropriate directions are issued to respondent No. 2, the Commissioner of Police, Police Commissionerate, District Ludhiana, to consider and dispose of the representation dated 03.01.2025 (Annexure P-6) in accordance with the law in an expeditious manner.

5. Notice of motion to the official respondents.

6. On the asking of the Court, Mr. Ankit Grewal, DAG, Punjab, accepts notice on behalf of the State-respondents No. 1 to 3 and submits that the aforesaid representation shall be considered and disposed of in an expeditious manner according to law.

7. After considering the rival contentions and considering the limited request made by learned counsel for the petitioner and without commenting on the merits of the case, the petition is disposed of with the direction to respondent No.2- the Commissioner of Police, Police Commissionerate, District Ludhiana, to consider and dispose of the representation dated 03.01.2025 (Annexure P-6) in accordance with law in an expeditious manner.
