SUDEEPTI SHARMA J. (Oral)

1. The present contempt petition has been filed for non-compliance of order dated 03.09.2024 passed by this Court in CWP-17338-2004, which was disposed of in terms of CWP No. 1048-2016, decided on 01.03.2019.

2. The relevant portion of order dated 01.03.2019 passed by this Court in CWP-1048-2016 is reproduced as under:-

“In view of the above, it is held that the petitioner is entitled for the pensionary benefits under the Old Pension Scheme and further the petitioner will be entitled for computing his service from 06.08.1992 till 27.02.2012 as a qualifying service for the grant of pensionary benefits.

Let the pensionary benefits be computed within a period of two months from the date of receipt of certified copy of this

order and the same be released to the petitioner within a period of one month thereafter.

Present writ petition stands allowed in the above terms.”

3. In compliance of the above referred to order, compliance report by way of affidavit of Dr. Jitender Kumar, Director Secondary Education, Haryana, Panchkula on behalf of respondent has been filed. The relevant portion of the same is reproduced as under:-

“3.That the case of the petitioners was examined by the Department and after examination it has been found that after receiving the approval from the Finance Department vide U.O No. 1/28/2025-2 Pension (FD)/20106 dated 16.09.2025, the department has issued sanction to the petitioners vide Order No. 13/40-2024 HRME (2) dated 17.09.2025.

4. *That the details of Old Pension Payment released to Petitioner No.1 (Annexure R-1) is as under:-*

4. A perusal of the above compliance affidavit shows that order dated 03.09.2024 passed by this Court in CWP-17338-2004 has been duly complied with.

5. In view of the above, the contempt is purged. Rule is *discharged*.
