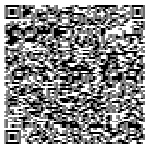

ASHWANI KUMAR MISHRA J. (Oral)

1. Since the controversy raised in the aforementioned appeals is same, they are being dealt with together by this common judgment.
2. Controversy raised in the present appeals stand finally adjudicated by a Coordinate Bench of this Court in LPA-1402-2025, titled as '*Preeti Malik and another vs. State of Haryana and others*', decided on 12.05.2025, wherein, this Court held as under:-

"We are of the firm view that we cannot interfere in the order passed by the Supreme Court. The exercise stands completed and closed after the final order dated 03.07.2023 passed in the review petition. The claim of the appellants solely on the basis that they are more meritorious than such 178 persons, is found to be without basis as the said 178 persons form a separate class

as recognized by the Supreme Court. No place of discrimination or violation of Article 14 of Constitution is thus, made out. The writ petition has been rightly dismissed.”

3. For the reasons recorded in Preeti Malik case (supra), the present appeals also stand dismissed.
4. All pending misc. application(s), if any, also stands disposed of.
