This is a under section 528 of BNSS with the prayer to direct the Respondent No.2 i.e. SSP Ferozepur to decide the Representation dated 12.03.2025 (P / 4) as well as Representation dated 01.02.2025 (P /2) in the office of Respondent No.3 submitted by the Petitioners in which request was made to take appropriate legal recourse so that the Petitioners can harvest their wheat crop in their fields as the Respondent No.5 to 8 are unnecessarily interfering into the peaceful possession of the land which is purchased by the Petitioners vide valid sale deeds but the Private Respondents forcibly want to harvest the wheat crop of the Petitioners under the political patronage and with the help of Respondent No.7 who is police official posted at Vigilance Office, Ferozepur and relative of Respondent No.5 but till date the Respondent No.2 and 3 had not taken any action on the representation submitted by the Petitioners as the harvesting season is starting soon and Private Respondents

are out and out passing on threats not to allow the Petitioner to enter into their fields thus the act of Respondent No.2 and 3 in not deciding the Representations, is not only arbitrary, discriminatory and against the principal of natural justice.

Learned counsel for the petitioners submits that the representations dated 01.02.2025, 07.02.2025, 12.03.2025 (Annexures P-2 to P-4) addressed to Senior Superintendent of Police, (Vigilance Department) Ferozepur are not being addressed by respondent No.2.

Notice of motion.

Mr. Jaspal Singh Guru, AAG Punjab, accepts notice on behalf of respondent/State and assures the Court that the above-said representations 01.02.2025, 07.02.2025, 12.03.2025 (Annexures P-2 to P-4) will be addressed and decided within a period of four weeks from today after providing an opportunity of hearing to the petitioners and by passing a speaking order in accordance with law.

A copy of order so passed be supplied to the petitioners within one week thereafter.
