This petition has been filed under Article 226 of Constitution of India praying for issuance of directions to respondents no. 1 to 3 to protect the life and the liberty of the petitioners from the hands of respondent no. 4 as both are living together in live in relationship against the wishes of respondent no. 4.

2. Today learned State Counsel has produced the speaking order dated 20.04.2025 passed by SHO, PS Zirakpur, the same is taken on record and is reproduced below :-

‘Whereas Akash S/O Balbir Singh R/O Village Lohgarh Police Station Zirakpur Distt S.A.S. Nagar & sunnina d/o santosh r/o at hardoi road andhey ki chowki mahipatmau tehsil kakori disst. Lacknow up. Now at village Lohgarh Police Station Zirakpur Distt S.A.S. Nagar had moved a writ petition bearing number crwp-3814-2025 before the SSP SAS Nagar. The complainants have mentioned in their complaint that they both are majors and they both are living happily in live in relationship against the wishes of their parents Santosh S/O Sheda Kumar (Father Of Sunaina) now they are apprehending danger to their lives at the hands of have demanded protection of their life and liberty.

During enquiry, complainant Akash S/O Balbir Singh R/O Village Lohgarh Police Station Zirakpur Distt S.A.S. Nagar & sunaina d/o santosh r/o at hardoi road andhey ki chowki mahipatmau tehsil kakori disst. Lacknow up. Now at village Lohgarh Police Station Zirakpur Distt S.A.S. Nagar appeared before undersigned and they have suffered a joint statement that now their parents have agreed with their live in relationship and they do not want any action on their compliant and also now they do not need any kind of protection. Even the opposite party Santosh S/O Sheda Kumar (Father Of Sunaina) were also joined enquiry on telephonic he said now he is present at lacknow and he will come at police station zirakpur after 20 may 2025 and he has suffered statement that he has no objection with live in relation of sunaina and Akash and also he will not interfere in life of the complainants and neither he has given any threats to them.

Keeping in view the abovementioned facts, no further action is required on this petition and this petition is being filed to record room. Copy of this speaking order is being provided free of cost to complainants. In case of dissatisfaction with these speaking orders, Complainants can appeal against these orders within 3

days from the date of receiving copy of these orders to DSP Crime against women (CAW), room no- 337, SSP Office, Secror-76, SAS Nagar.'

In light of the above said speaking order, it is crystal clear that no further action is required as nothing survives in the present petition, hence, the same is disposed of as having been rendered infructuous.

However, the petitioner would be at liberty to file appeal as is stipulated in the Standard Operating Procedure as per law, in the light of notification No.HOME-HM-40 40SECM/14/2025-2H4/63 dated 23.01.2025 issued by the Department of Home Affairs, Punjab, Government of Punjab (Home-4 Branch), in case of any grievance left after passing the speaking order.
