This petition has been filed under Section 482 of Criminal Procedure Code, 1973 with a prayer of directing the directing the respondent no. 1 to 4 to take appropriate legal action against respondent no. 5 who is trying and making an attempt to forcibly take away the Truck/vehicle of the petitioner bearing registration number (PB-46 W 8455) with the help of recovery agents and henchmen while it was running on road, despite the fact that the petitioner is regularly paying the loan amount, as this conduct of respondent no. 5 is against the mandate of constitutional bench of Apex court in "*Citicorp Maruti Finance Ltd. v/s S Vijayalakshmi 2012(1) SCC 1*" and in "*ICICI Bank Ltd. Vs Parkash Kaur and others (JT-2007(4) SC 39)*", and by

this Court in '*Narinder Kumar Singla Vs State of Punjab (2006 (3) RCR 890*), '*M/s Sundaram Finance Ltd v/s Raj Kumar & others 2011 (4) RCR (Crl) 890*.

None has put in appearance on behalf of the petitioner since 25.04.2024. Today also there is no representation on his behalf. It seems that counsel for the petitioner is not interested in pursuing the matter.

Hence, the petitioner stands dismissed for non-prosecution.
