1. These petitions have been filed under Section 482 Cr.P.C.
seeking quashing of FIR No.163 dated 01.03.2019 under Sections
406/420/506 of IPC registered at Police Station City Bhiwani, District
Bhiwani (Annexure P-1) along with all subsequent proceedings arising
therefrom on the basis of compromises dated 15.10.2024 and 04.04.2025
respectively (Annexure P-2).

2. The following order was passed on 30.04.2025:

under Sections 406/420/506 of IPC registered at Police Station City Bhiwani, District Bhiwani (Annexure P-1) along with all subsequent proceedings arising therefrom on the basis of compromises dated 15.10.202 and 04.04.2025 respectively (Annexure P-2).

Adjourned to 27.05.2025.

In the meanwhile, the parties are directed to appear before the learned trial Court/Illaq Magistrate within two weeks from today or any other date convenient to the trial Court/Illaq Magistrate, to get recorded their statements regarding compromise and after recording their statements, learned trial Court/Illaq Magistrate is directed to send report regarding the genuineness of compromise and also to intimate whether any PO proceedings are pending against any of the party on or before the date fixed.

A copy of the order be sent to learned trial Court/Illaq Magistrate through fax for compliance.

A photocopy of this order be placed on the file of other connected case.”

3. In compliance of the aforesaid order, a report has been received from the concerned jurisdictional Court that the compromise between the parties is genuine and arrived at without any pressure or coercion from anyone.

4. Learned State counsel at the outset submits that Section 201 of IPC has been added in the FIR(supra) later on and the same has not been mentioned in the headnote and prayer clause of the petition.

5. Faced with the above, learned counsel prays that the aforementioned Section may be added in the headnote and prayer clause of the present petition on his oral request.

6. Allowed as prayed for.

7. Section 201 of IPC be read as part of the other Sections mentioned in the FIR(supra) in the headnote and prayer clause of this petition.

Registry is directed to make the necessary corrections.

In view of the compromise and the ratio of law laid down by the Hon'ble Supreme Court in **Narinder Singh and others vs. State of Punjab and another, (2014) 6 SCC 466** and **Shakuntala Sawhney (Mrs) Vs. Kaushalya (Mrs.) and others (1980) 1 SCC 63** and Full Bench of this Court in **Kulwinder Singh Vs. State of Punjab 2007 (3) RCR (Cr1.) 1052**, this petition is allowed and FIR No.163 dated 01.03.2019 under Sections 406/420/506/201 of IPC registered at Police Station City Bhiwani, District Bhiwani (Annexure P-1) along with all subsequent proceedings arising therefrom are quashed, qua the petitioners.
