1. The present petition has been filed under Section 528 of Bharatiya Nagarik Suraksha Sanhita, 2023 (for short-'BNSS') for quashing of DDR No.42 dated 14.06.2024 under Sections 324, 323, 148, 149 IPC (Offence under Section 326 IPC added subsequently) registered at Police Station Bahawala, District Fazilka (Annexure P-2) in FIR No.0063 dated 14.06.2024, under Sections 324, 323, 148, 149 IPC, (offence under Section 326 IPC added subsequently) registered at Police Station Bahawala, District Fazilka (Annexure P-1) and all the subsequent proceedings arising therefrom, on the basis of compromise/affidavit dated 25.08.2024 (Annexure P-3).

2. Notice of motion.

3. Mr. M. S. Toor, AAG, Punjab and Mr. A. K. Khunger, Advocate, accept notice on behalf of respondent No.1-State of Punjab and respondent No.2 respectively.

4. Learned counsel for respondents No.1 & 2 confirm the factum of the compromise having been effected between the parties and states that they



have no objection to the quashing of the FIR in question. The original affidavit dated 25.08.2024 has been annexed as Annexure P-3 with the main petition.

5. In that view of the matter, even if this case is taken to its logical conclusion, it would only be an exercise in futility as the parties have already settled their differences. Therefore, no useful purpose would be served in wasting the time and resources of the State in pursuing this case to its pre-ordained end. It would, therefore, be better to give a quietus to the issue at this stage.

6. Accordingly, the petition is allowed and DDR No.42 dated 14.06.2024 under Sections 324, 323, 148, 149 IPC (Offence under Section 326 IPC added subsequently) registered at Police Station Bahawala, District Fazilka (Annexure P-2) in FIR No.0063 dated 14.06.2024, under Sections 324, 323, 148, 149 IPC, (offence under Section 326 IPC added subsequently) registered at Police Station Bahawala, District Fazilka (Annexure P-1) and all other consequential proceedings arising therefrom qua the petitioner shall stand quashed.
